 - 2) Final Merit No. print out (Not required for NON CAP)
 - 3) FC confirmation copy,
 - 4) CET Score card (not required for diploma candidates),
 - 5) HSC mark list/Diploma III marklist,
 - 6) SSC mark list,
 - 7) Nationality certificate,
 - 8) Domicile Certificate,
 - 9) Caste Certificate (CC) [if applicable],
 - 10)Caste Validity certificate(CVC) [if applicable],
 - 11)Non Creamy Layer(NCL) [if applicable]
4. Candidates must be physically present with all originals and required fees for the counselling round on 24/08/2023 at 10.30 AM as per schedule.

Important Instructions:

1. The admissions to the first year of undergraduate courses at **Government College of Engineering and Research Avasari Khurd-412405** for the **Academic Year 2023-24** will be conducted by direct counselling (**On The Spot**) Round only.
2. Only those candidates, whose names appear in the final merit list published by CET cell. Candidates registered for the **NON CAP** round are also eligible. **No fresh applications will be considered.**
3. These admissions will be made strictly in the order of *inter se* merit from amongst the candidates who report in person for admission to **Government College of Engineering and Research Avasari Khurd** against the seats available in various branches at the time when the candidate actually reports for admission by counselling.
4. Candidates will lose claim to participate in the admission counselling process, if he/she fails to produce ALL the applicable original documents at the time of document verification during the counselling round. **In case a candidate has taken admission elsewhere he/she will be required to submit/produce original fee receipt and admission confirmation letter. In this condition the candidate should submit undertaking stating that original documents will be submitted by him/her within four (4) working days from the date of reporting and if candidate fails to produce original documents in stipulated period then his/her admission will be cancelled and fees paid will be forfeited.**
5. After successful verification of the applicable original documents eligible candidates will be called for seat allotment by counselling as per *inter se* merit.
6. The seat allotment will be carried out based on the vacancy status at that point. Seat allotted, accordingly, to a candidate would then be deleted from the pool of vacant seats.
7. **If seat is allotted to the candidate** then he/ has to pay admission fees by online transaction through **SBI Collect (<https://www.onlinesbi.com/sbicollect/icollecthome.htm>)** for this candidate can use internet banking/credit card/upi-id facilities.

9. **EBC (Rajarshi Shahu Maharaj Scholarship) facility and Punjabrao Deshmukh Nivah Bhatta are not applicable to candidates admitted through ACAP (Against CAP seat/SPOT round).**
10. If a candidate is found unavailable when called, the next candidate on the merit rank would be called for allotment of seat and the unavailable candidate may miss his/her chance of merit based seat allotment.
11. If a candidate of higher merit reports late during the process of counselling, the candidate may be considered for allotment of a seat available at that point of time for a particular category to which

he/she belongs. Such a candidate shall be given preference for admission over the candidates with lower rank present at that point of time. The decision of the admission committee shall be final and binding.

12. Confirmation of the allotted seat to the candidate is subject to the submission of requisite admission fees, original documents and anti ragging format immediately. This candidate confirms the admission through the acceptance of allotted seats at this institute.
13. If a candidate fails to pay the requisite institute admission fees then the seat allotted to such candidature will be withdrawn and the seat will be allotted to the next candidate on the merit list. Part payment will not be accepted under any circumstances.
14. Candidates already admitted in this institute and willing to change course can also attend this round.
